- 4. **Option 2:** Only 50 mm Aluminium Venetian blinds with a slab thickness of 0.21 mm will (matte dark brown in color). The fitting type is recess and the controller is on the right-hand side.

- 6. The successful bidder must provide their own equipment, tools and small plant that will be required to complete the project successfully.

 - (d) recommend that the bidder or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted by the National Treasury from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
 - (e) forward the matter for criminal prosecution.
