- Weekly cleaning of nine (9) transfer stations located in the Noord End Area on Mondays and Thursdays.
- Cleaning must involve labor-intensive methods that consist of loading refuse with hand or spade and clearing up the transfer station with a rake.
- All refuse (household, garden or building) must be transported to and dispose of at the Prince Albert landfill site at the demarcated cells.
- Operation / Working hours 09:00 – 16:00

- Workers must at all times be properly identified by wearing reflector bibs.
- Workers must at all times wear the appropriate personal protective equipment (e.g hand safety gloves, dust masks)

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
