Building must be painted with a good quality of universal undercoat and then with a premium final coat. This includes the outside buildings and boundary walls. Same color paint as the current. The final coat needs to be painted with an extra thick acrylic PVA based paint.

  - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
  - (d) recommend that the bidder or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted by the National Treasury from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
  - (e) forward the matter for criminal prosecution.
