1. **BACKGROUND**

The purpose of this Request for Quotation is to appoint a service provider to undertake **topographical surveys**, at 2 of the Prince Albert Municipality's Solid Waste Disposal Facilities. The service provider would also be required to do a volume determination of the compacted waste body at one of the facility's and an available airspace determination at the other. The following are the sites to be surveyed:

- Klaarstroom Waste Disposal Facility, approximately 5 260 m<sup>2</sup>;
- Prince Albert Waste Disposal Facility, approximately 9 440 m<sup>2</sup>;

Topographical surveys are required to scientifically determine available landfill airspace, as well as determining the volume of compacted waste. The accuracy of the results of these surveys is critical and must be undertaken by a professionally competent and experienced volumetric topographical surveyor.

## 2. REQUIREMENTS

- a) Provide air space calculation report and Long Section for the Klaarstroom Waste Disposal Facility as well as survey map in the form of electronic and one hard copy;
- b) Provide a report on the volume of compacted waste disposed at the Prince Albert Waste Disposal Facility and a survey map.
- c) The survey results must be presented in the form of a survey plan, showing survey results to the licensed boundaries of the landfill site at the time of the survey.
- d) The terrain levels must be represented on the survey plan by contours at not more than 1 metre intervals.
- e) The spot levels must be taken at sufficient frequency to allow interpolation of levels from the survey plan to  $\pm 0.5$  metres at the 90% confidence level.
- f) The survey plan must include amongst others the boundaries of the site or cells, date of survey, adjoining title information, scale bar, buildings, roads, fences, ponds, landfill cell extraction areas, weighbridges, settlement, subsidence and any other significant details that will likely impact on the volume usage are noted on the survey plan.
- g) The boundaries of all active cells which received waste during the survey period must be noted on the survey plan.
